



Denbigh Harriers Privacy Policy

Denbigh Harriers Running Club are committed to protecting and respecting your privacy. For any personal data you provide for the purposes of your membership, Denbigh Harriers Running Club is the Data Controller and is responsible for storing and otherwise processing that data in a fair, lawful, secure and transparent way.

In delivering its services Denbigh Harriers will need to collect information about its Members and share the information with Welsh Athletics and other bodies. All such processing is subject to the General Data Protection Regulation (GDPR) and the Data Protection Act 2018. This policy sets out the Club's intentions in fulfilling its obligations under this legislation.

What personal data we hold on you?

You may give us information about you by filling in our Membership form online when you register with the club, or by corresponding with us by phone, e-mail or otherwise. The information you give us may include your name, date of birth, address, e-mail address, phone number, gender, name of other WA affiliated Clubs with which you are registered.

Why we need your personal data?

The reason we need your Athletics Data is to be able to administer your membership, and provide the membership services you are signing up to when you register with the club. Our lawful basis for processing your personal data is that we have a contractual obligation to you as a member to provide the services you are registering for.

Reasons we need to process your data include:

Sharing your data with Welsh Athletics. When you become a member of Denbigh Harriers Running Club, you will also automatically be registered as a member of Welsh Athletics. We will provide Welsh Athletics with your Athletics Data. Welsh Athletics will contact you to invite you to sign into and update your MyAthletics portal. You can set and amend your privacy settings from the MyAthletics portal. If you have any questions about the



continuing privacy of your personal data when it is shared with Welsh Athletics Limited, please contact Welsh Athletics.

The Club does not supply any personal data it holds for this purpose to any other third party. The Club does not store or transfer your personal data outside of the UK.

We may also share your information for training and competition entry

- sharing personal data with club coaches or officials to administer training sessions;
- sharing personal data with club team managers, leagues, county and regional associations and to enter events e.g. team events on roads, team events on fells, regional and inter-regional cross country events, national cross- country events, and other competition providers for entry in events.

For funding and reporting purposes

- sharing anonymised data with a funding partner as condition of grant funding e.g. Local Authority;
- analysing anonymised data to monitor club trends; and
- sending an annual club survey to improve your experience as a club member

For membership and club management

- processing of membership forms and payments;
- sharing data with committee members to provide information about club activities, membership renewals or invitation to social events;
- club newsletter on the Web site promoting club activity; and
- publishing of race and competition results

On occasion we may collect personal data from non-members, for example in relation to the club's Run for Fun programme (a programme supported by our qualified Run Leaders to encourage members of the community to start running). This information will be stored for 1 month or the duration of the activity it relates to and then destroyed securely. Our lawful basis for processing data is consent. Therefore, we will also need explicit consent from non-members to process this data, which we will ask for at the point of collecting it.

The club has the following social media pages - A web site and a Closed Facebook page. All members are free to join the Facebook Page. If you join



the Facebook group please note that provider of the social media platform(s) has their own privacy policies and that the club do not accept any responsibility or liability for these policies. Please check these policies before you submit any personal data on the club social media page.

How long we hold your personal data

We will hold your personal data on file for as long as you are a member with us. Athlete data is updated every year on online membership forms. Any personal data we hold on you will be securely destroyed after six years of inactivity on that member's account, in line with Welsh Athletics Limited's retention policy. Your data is not processed for any further purposes other than those detailed in this policy.

Your rights regarding your personal data

As a data subject you may have the right at any time to request access to, rectification or erasure of your personal data; to restrict or object to certain kinds of processing of your personal data, including direct marketing; to the portability of your personal data and to complain to the UK's data protection supervisory authority, the Information Commissioner's Office about the processing of your personal data.

As a data subject you are not obliged to share your personal data with the Club. If you choose not to share your personal data with us we may not be able to register or administer your membership.
